#### **ORDER**

This relates to the appeal dated 12.12.2024 filed by Shri Dhanraj Bagrecha on the grounds that the CPIO had not provided requisite information on his RTI application dated 04.11.2024.

- 2. The records related to the original application dated 04.11.2024 were called for and it is observed that the applicant had used the RTI platform to seek information related to the Harassment case of Shri Divya Bagrecha/Fraud Foreign Posting in IOCL. Since, the information sought through the RTI application did not pertain to this Secretariat, The CPIO/Under Secretary, vide letter dated 25.11.2024 had provided NIL information.
- 3. Reference is invited to Section 2(f) of the RTI Act, 2005 which defines "information" as any <u>material</u> in any form, including records, documents, memos, emails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.
- 4. In the light of the present appeal filed by the appellant requesting for 'information' related to other Public Authority, it is reiterated that this Secretariat does not hold any relevant. information sought by the appellant through his RTI application and accordingly supplied NIL information.
- 5. The appellant may note that there is no obligation to transfer the RTI application received from educated persons by this Secretariat that pertain to other Departments as observe by the CIC in its Order (No. CIC/SA/A/2016/001483) dated 01.08.2016.
- 6. With the above observations, the appeal is disposed of without any further action and is hereby advised to desist sending the RTI applications to this Secretariat for the matters related to other Departments and to seek information directly from the public authorities concerned.

Please refer to your RTI application dated 11.11.2024 registered in this Ministry vide registration No. MOPNG/R/P/24/00239 dated 19.11.2024 seeking information under RTI Act, 2005.

- 2. You have requested to provide the certified copy of letter No.P-29016/120/2016-IOC/6775 dated 20.03.2017 which was addressed to Private Secretary to Hon'ble MoS (I/C) for Skill Development & Enterpreneurship from Private Secretary to the Hon'ble MoS (I/C) for PNG and also for providing a certified copy of IOCL's letter dated 10.06.2011 which is mentioned in the letter dated 20.03.2017.
- 3. It was earlier informed, vide this Ministry's letter dated 29.03.2023 (copy enclosed) that the letter No.P-29016/120/2016-IOC/6775 dated 20.03.2017 was dealt in general/PG/complaint file and such files are not preserved in the section for a very long time as per retention schedule mentioned in Manual of Office Procedure and also that, neither the record of weeding out of this file nor the file itself will be provided once the file is traced. However, it is mentioned that despite best of efforts, the concerned file/letter has not vet been traced out.
- 4. As regards IOCL's letter dated 10.06.2011, as the matter pertains to IndianOil Corporation Ltd. (IOCL), therefore, the RTI application is being transferred under Section 6 (3) of the RTI Act, 2005 to IOCL for providing the requisite information to you directly.
- 5. In case, you do not receive or not satisfied with the information provided by CPIO, IOCL, you can make appeal with the 1<sup>st</sup> Appellate Authority of respective Organization. If you are not satisfied with the information provided by Under Secretary (OMC) & CPIO, you can make an appeal to the 1<sup>st</sup> Appellate Authority within 30 days from the receipt of this communication at the following address:



#### **ORDER**

1<sup>st</sup> appeal dated 23.02.2023 registered in this Ministry vide registration No. MOPNG/A/P/23/00004 dated 02.03.2023 against the reply dated 06.01.2023 provided by CPIO, MoPNG in response to the RTI application dated 24.12.2022 registration no. MOPNG/R/P/23/00004 dated 03.01.2023 has been brought before me.

- 2. I have found that the appellant had not sought any specific information in his RTI application. However, with the RTI application the applicant had attached few correspondences that he had made various Govt. authorities like Chief Minister Office. Govt. of NTC of Delhi, Lokpal of India and Private Secretary to Hon'ble MoS (I/C) for Skill Development & Enterpreneurship etc. alongwith some hand written notes on the said correspondences which suggest that the matter pertains to foreign posting of his son working in IOCL. Hence, the RTI application was transferred to CPIO, IOCL under Section 6 (3) of RTI Act, 2005 for providing the requisite information to the applicant directly. IOCL has also provided the information to the applicant vide letter dated 03.02.2023.
- 3. In the appeal dated 23.02.2023 appellant neither mentioned any ground for appeal nor has sought any specific information. However, he has again attached the same correspondences that he attached with his RTI application dated 24.12.2022 along with some new correspondences made by him with Govt. Authorities. Further, on one of the correspondences addressed to Private Secretary to Hon'ble MoS (I/C) for Skill Development & Enterpreneurship from Private Secretary to the Hon'ble MoS (I/C) for PNG having file No.P-29016/120/2016-IOC/6775 dated 20.03.2017, he has mentioned that he wants a certified copy of the said letter.
- 4. It is thus, observed that the reply given by CPIO, OMC is in order. So far as true copy of letter No.P-29016/120/2016-IOC/6775 dated 20.03.2017 is concerned, it has been informed that this reference was dealt in general/PG/complaint file and such files are not preserved in the section for a very long time as per retention schedule mentioned in Manual of Office Pprocedure. However, neither the record of weeding out of this file nor the file itself has been traced so far. Efforts are being made to trace the concerned file and true copy of the letter will be provided once the file is traced.
- 5. Appellant is, therefore, advised that he may prefer an appeal, if he is not satisfied with the reply dated 03.02.2023 of IOCL to the 1<sup>st</sup> Appellate Authority of IOCL.



- 6. In view of the above, the Appeal dated 23.02.2023 is hereby disposed off.
