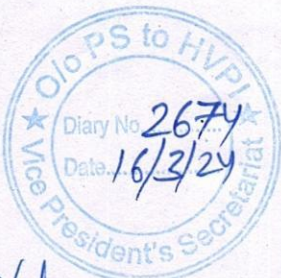
I believe that transparency and accountability are essential in ensuring fair and just practices in educational institutions. Therefore, I kindly request that you provide the requested information at your earliest convenience.
