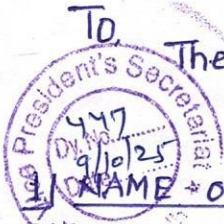

3. Details of Information sought under the R.T.I. Act. 2005, below :-

- (i) CMC, Vellore is forcing patients to abandon their treatment midway due to unnecessary tests for 20-25 days, prescribing unnecessary and excessive medications in the name of chemotherapy, forcibly charging exorbitant fees for accommodation under emergency arrangements, treating patient's relatives rudely and especially, under the guise of linguistic incomprehensibility, extorting amounts from patients coming from Hindi states like BIHAR. This is tarnishing the reputation of the 125 years old C.M.C., Vellore. Information should be provided regarding this, Please.
- (ii) If a patient lacks the amounts, CMC, Vellore forcibly removes them from treatment, Please provide information regarding this.
- (iii) CMC, Vellore is deliberately prolongs treatment. Due to the lack of its lodging and dining facilities in CMC, patients and their families are forced to stay in nearby hotels, incurring significant financial costs. Information should be provided on the CMC administration's actions to stop this plunder.
- (iv) There (CMC) are no arrangements for vegetarian patients and their family members in the canteens located within CMC and outside its premises. Eggs, mutton, chicken and fishes are served from the same ladle/spoon, followed by vegetables. We will provide information on the CMC administration's procedures for arranging meals for vegetarian patients and their attendants.
