With due respect I would wish to bring to our kind notice that Dr. Gurdeeep Sharma, Principal GGDS College, Hariana District, Hoshiarpur (Punjab), a member of Punjab University syndicate/senate is nominated as a Vice-Chancellor nominee on most of the Selection Committees constituted for the selection of Principals in various colleges especially located in Hoshiarpur District Being in commanding position due to VC nominee, he forced the concerned managing committee to select the candidate of his choice irrespective of very low merit and from candidate so selected, he takes promise to cast vote in senate election to him or his wife Mrs. Nisha Bhargav, Principal MCM DAV college for women, Chandigarh or his bosom friends contesting election. Thus, either ineligible or incapable or both type of candidates have a chance to enter higher education arena on account of which quality education is suffering tremendously to which GOI is seriously concerned.
