**Subject:** First appeal u/s 19(1) of RTI act 2005.

**Reference RTI application:** DOEXP/R/E/20/00461 ,

Respected Sir,

Please note **Reference RTI application and reply provided by CPIO is already available with CPIO.**

This appeal is due to information is not well received and RTI has been disposed of in malefic manner. Applicant has requested information on **"Basic salary per month with Other emoluments and Allowances as per FY2020"** of different people working in Govt. including PM and President of India.

**Please note, I have asked the salary offered to the Posts not of the Individual person.**

**Applicants thinks CPIO is not aware of the 6(3) of the RTI act and has not read the RTI.**

**Applicant want to share the example of one of his RTI application "DOP&T/R/T/20/01029" where information about people working in different departments was asked, CPIO at DOPT transferred RTI to 25 departments and Every department ensured that Information will be delivered to applicant within specified time**

*which is held by another public authority; or the subject matter of which is more closely connected with the functions of another public authority, the public authority, to which such application is made, shall transfer the application or such part of it as may be appropriate to that other public authority and inform the applicant immediately about such transfer: Provided that the transfer of an application pursuant to this sub-section shall be made as soon as practicable but in no case later than five days from the date of receipt of the application.*

12) CPIO has failed to follow 6(3) of RTI act where CPIO states that Information is available at multiple departments i.e with more than one public authorities.

13) CPIO should always follow the process to ensure information is delivered to applicant.

**Grounds to take action on CPIO:**

- a) In RTI if pertaining to different departments then its duty of CPIO to inform applicant to share details of departments and first appellate authority transfer RTI to departments as per 6(3) of the act.
- b) Applicant don't see that in his response. This is failure from CPIO.
- c) CPIO ignored the fact that information requested by applicant in pointwise manner however CPIO just one line in his reply which is not sufficient, this is not something which was asked in RTI application, Information was asked about all points. It seems CPIO has not read those points.
- d) CPIO to inform applicant to which department information is to be available, CPIO also should ensure that he will give first appellate authority details as well, CPIO has not done that
- e) CPIO has not mentions reasons for denial about information availability, hence this information is available and can be given in pointwise manner, Hence Information must be provided under RTI act under section 2(F).
- f) CPIO has rejected RTI in malefic manner and is not aware of RTI guidelines and procedures.
- g) It can be seen that CPIO has not read the complete RTI which includes information requested for all points of original RTI.
- h) CPIO instead of following process defined 6(3) of RTI act, provided false one liner reply which cannot be understood by applicant.
- i) Action of CPIO is against the spirit of RTI act.

Please note that I request you to provide the information at the earliest. If not I'll be compelled to Approach the Chief Information Commissioner &/ or High Court /Supreme court &/ or Consumer Redressal Forum &/ or <http://www.pgportal.gov.in> for any attempt to restrict the flow of information Guaranteed vide Constitution of India vide RTI Act'2005.

In a welfare state, such as ours, right to information of every individual is a matter which involved the state. Therefore, large public interest is involved in this request. Hence requesting you to provide information.
