Sub: Regarding restoration of my registered vitilands which have been allotted by the BL&LRO/Farakka ^{in consultation} ~~in connection~~ with SDL&LRO/Jangipur, Govt. of West Bengal to the unauthorised people without any intimation to the real owner of the Registered lands.

Reverend Sir,

I am enclosing herewith the following corresponding letters with a request that you will go through the letters which will help you to apprehend my problem regarding subject mentioned matter.

- 1) My letter No. 438(3)(we) dt. 05-03-16 addressed to the Hon'ble Governor of West Bengal, Raj Bhavan, Kolkata - 700 062 regarding subject mentioned matters & copy to you & others.
- 2) My letter No. 75(we)(4) Dt. 20-06-16 addressed to the Commissioner of Police, 18-Lalbazar Street, Kolkata- 700 001 & copy to you & others.
- 3) My letter No. 76(5)(we) Dt. 18-07-16 addressed to the DM/ Murshidabad & copy to you & others.

As it is a long pending case. In spite of numerous ^{number} of correspondences with the Ministers and Officers, my problem of restoration of my registered vitilands have not yet been solved. The BL&LRO/Farakka sent me so many notices with necessary instruction to attend his office on hearing dates with all the relevant records to prove the ownership of the registered vitiland which have been allotted by them to the unauthorised person. I attended on each hearing date and produced all the records which satisfied the BL&LRO/Farakka. In spite of the same I am being harassed till to day & no action for restoration of my registered vitilands are being ^{taken} ~~done~~ by him till to date.

Under the circumstances I would request you that being powerful Vice-President ^{of India} you will kindly look into the matter. Sir, not only you but also all the Ministers and Officers are sitting on the VIP Chairs to look after the misery of suffering citizens of India & to solve their problems. But inpractical it is found

that they are obtained from doing their proper duties and to obey their responsibilities.

But you are ~~at~~ absolutely different from other Ministers & Officers. If you feel inconvenience to take legal action against the BL&LRO/Farakka & SDL&LRO / Jangipur who have illegally allotted my registered vitilands, violating law. Tehn you kindly arrange to send either CBI or Vigilence for ~~spot spot~~ verification at Kendua & Jafarganj Mouza under Farakka P.S. then the truth will come out & I shall get the opportunity to receive back my vitiland, otherwise, you give me necessary instruction where shall I have to go for rescue of my vitiland.

I hope you will do the needful.
