*The Pondicherry University Vice Chancellor(i/c) Prof.Anisa B Khan, The Registrar(i/c) Mr.M.Ramachandran, The Joint Registrar(Admn) Mr.P.Subramanian received for my several representations and also not consider the enquiry committee report against the illegal appointment of Ms.Tasneem Abbasi, with the religious wise sympathy of the VC(i/c) Prof.Anisa B Khan, That reason only I have submit for my grievance's petition's to The Chancellor of Pondicherry University-cum-The Vice President of India and also Hon'ble Chancellor of Pondicherry University as Responsible authority of the Pondicherry University maladministration :

- A. The Vice Chancellor Secretariat, The First Appellate Authority cum The Registrar and The Public Information Officer cum The Deputy Registrar of Pondicherry University; to obey and Answerable authority to obey the Order of The Central Information Commission under RTI Act.,2005?, and to follow the CIC order No. CIC/SS/A/2012/003620 dt.30-08-2013 ?, Legally its correct?. Encouraged by The Vice-President of India?, If, Yes, Please furnish full details and copy of the related documents to me, Please refer the Annexure Page No. 13 to 21
- B. The enquiry committee report comes under final stage to initiation of action till date not to initiation of action against Ms.Tasneem Abbasi, and not to hand over the enquiry committee report to me, Legally its correct?. Encouraged by The Vice-President of India?, If, Yes, Please furnish full details and copy of the related documents to me, Please refer the Annexure Page No 13 to 21
- C. In The CIC order No. CIC/SS/A/2012/003620 dt.30-08-2013 by The P.I.O cum The Deputy Registrar(Admn) Mr.P.Subramanian send a call letter to me PU/Estt(T)/ET-4/2013-14/175 dt.29-08-2013, I was appeared in front of this enquiry committee and submitted the related documents and also informed, for my WP.No.34151 of 2012 pending in Madras High Court to the Committee Members. But till date I am not received the information about the Enquiry Committee Report as Per the CIC Order, Legally its correct?. - D. There are too many twist turns and contradictions in illegal appointment of Miss.Tasneem Abassi. In this regard a committee has been constituted under the Chairmanship of a retired Judge. The committee submitted its report, Which is against Miss.Tasneem Abbasi. They said report was placed in the 119th EC meeting of Pondicherry University held on 24-11-2014. But the decision taken in the said EC meeting has not deliberately implemented and the incumbent was made to continue illegally for the reasons best known to the present VC(i/c) Prof.Anisa Basheer Khan, Pondicherry University. Any F.I.R filed/pending against Dr.N.Dastagiri Reddy, Legally its correct?. - S. The Vice Chancellor Secretariat of Pondicherry University, The First Appellate Authority cum The Registrar and The Public Information Officer cum The Deputy Registrar(Admn) Mr.P.Subramanian given more importance to the stay order received by Dr.N.Dastagiri Reddy's Writ Petition No.4192 of 2015 than the RTI Act., 2005 in the Case No.CIC/SS/A/2012/003620 dated on 30-08-2013 the Point No.4.5, all of them joined together playing a dram and protect to initiation of action as per the Report of the Enquiry Committee, they all are act in favor of Ms.Tasneem Abbasi and Prof.S.A.Abbasi, I would to receive the Report of the Enquiry Committee as Documents helpful to Challenge for my WP.No.34151 of 2012 in future, The Hon'ble Chancellor of The Pondicherry University consider for my request to give the direction and handover the enquiry committee report to me. 13 to 21.
