For my complaint with attachment files submitted to Hon'ble Vice President of India cum The Chancellor of Pondicherry University in the E-Mail-ID: 'presidentofindia@rb.nic.in, pstopresident@rb.nic.in, vpindia@sansad.nic.in, secyvp@nic.in, ashok.dewan@nic.in, arvind.kapoor@nic.in, mahitab.singh@nic.in, pressesecyrb@gmail.com' I had submitted several representation/complaints in front of The Vice-Chancellor(i/c) Prof.Anisa B Khan, The Registrar(i/c) Mr.Ramachandran, The Finance Officer, The Controller of Examination, The Joint Registrar(Admn) and The Assistant Registrar(Estt.) of Pondicherry University and The Govt., of Puducherry-The Chief Secretary Mr.Manoj Paridha, The Inspector General of Police and The Deputy Inspector General of Police also not consider for my Representation because all are joint together involved allegation activities, not done proper way of initiation of action for my representations. That reason only, I have submitted for my grievance petitions to the Hon'ble Vice President of India cum The Chancellor of Pondicherry University. In the year of 2009 & 2010 The Vice-Chancellor Secretariat of Pondicherry University received the Ms.Tasneem Abbasi's OBC certificate cancellation order No.1822/DRDM/C.2/2009 dt.25-06-2010 from The Collector cum District Magistrate, Dept. of Revenue and Disaster Management, Govt. of Puducherry. Not followed the OBC-reservation policy as per UGC and Not obey the Law & Justice as per O.M.No.42011/22/2006-estt.(Res.) dt.29.3.2007 and O.M.No.36011/1/2012-estt.(Res.) dt.10.01.2013. issued by the Dept. of Personnel & Training Establishment (Reservation) Section, Govt. of India, repeatedly issued the appointment order to Ms.Tasneem Abbasi dt.03-12-2010 under General Category in CPCEE-Pondicherry University, In regards this illegality and Not obey this G.O at present Ms.Tasneem Abbasi continue her position at present in CPCEE-Pondicherry University. - O. Failure of the implementation of the O.M & G.O. mentioned in the Query-K & L, The Vice-Chancellor Secretariat repeatedly issued the appointment orders to Ms.Tasneem Abbasi dt.03-12-2010 under General Category in Center for Pollution Control Environmental Engineering, Pondicherry University. The Vice-Chancellor Secretariat of Pondicherry University after received the Ms.Tasneem Abbasi's OBC certificate cancellation order No.1822/DRDM/C.2/2009 dt.25-06-2010 from The Collector cum District Magistrate, Dept. of Revenue and Disaster Management, Govt. of Puducherry. Till date not to initiate any action/Disciplinary Proceedings against Ms.Tasneem Abbasi and continue her position in Pondicherry University, Legally its correct?, The Ministry of Human Resources Development only responsible and Answerable Authority of to take action against the erroneous officials of Pondicherry University. - P. The requested information and related documents highlighted in above mentioned Query-A to O: Clearly says the abuse of powers vested with the then VC Prof.J.A.K.Tareen. There are too many twist turns and contradictions in illegal appointment of Miss.Tasneem Abbasi. *In this regard a three members committee has been constituted under the Chairmanship of a retired Judge. The committee submitted its report, which is against Miss.Tasneem Abbasi. They said report was placed in the 119th EC meeting of Pondicherry University held on 24-11-2014.* But the decision taken in the said EC meeting has not deliberately implemented and the incumbent was made to continue illegally for the reasons best known to the present VC(i/c) Prof.Anisa Basheer Khan, with the illegal/allegation activities of the Pondicherry University Teachers Association(PUTA) General Secretary Dr.N.Dastagiri Reddy filed Writ Petition No.4192 of 2015 received the Stay Order due to these help of this association still escaped their criminal activities to deferred to initiation of action as per these three members enquiry committee report, The Hon'ble Chancellor of Pondicherry University only responsible authority. In the light of the above, Shri.P.Subramanian, Joint Registrar (Admn) may not be relieved from service on VRS until he hand over the three Members Committee Report officially to the authorities of the University as the order of the CIC to furnish the report to me has not yet honored by him. Further I am to state that Shri.P.Subramanian has informed the Hon'ble Vice President of India and the officer on special duty, office of the Hon'ble Prime Minister of India that the Enquiry Committee Report is very much available which has been placed in the Executive Council Meeting held on 24-11-2014 through his letter dt.19.10.2015.
