Dear Sir,


Kindly provide me complete and proper answer to my genuine question for the sake of all concerned have enclosed Postal Order no.- 32F 217311 worth Rs. 10/- as the fee under RTI Act.

Q.-1 : What is the Post & Rank/Pay Scale wise permissible sanctioned Staff strength in Vice President India Secretariat as per the Constitutional provisions ? And, what is the present strength of Staff in Vice President Secretariat Post & Rank/Pay Scale wise ? And, what is the reason of such grave difference now. **As till six years ago, VP Sectt. was headed by a Joint Secretary level Secretary who was assisted by one Deputy Secretary level officer and one Caretaker of Under Secretary level. And presently this Secretariat has one full fledged Secretary level officer who is assisted by Two Joint Secretary level officer (one from Rajya Sabha) and one Director level officer. JS level officer from Rajya Sabha holding Four Important Government posts altogether viz. CEO of RSTV, Executive Producer of RSTV, Joint Secretary in RS Sectt and lastly as OSD to Chairman, Rajya Sabha. Why is it so ?**

Q.-2 : Why Government of India is under so much grave pressure to distort and favourably change all its Rules and Regulations just to appease Vice President Sectt. by continuously upgrading the post of a Caretaker who was first absorbed as ex-cadre Under Secretary level officer in VP Sectt and then promoted as a Deputy Secretary, and after that promoted as a Director and very recently again promoted as a Joint Secretary ? This ex-serviceman was previously worked as ADC to then Governor of Andhra Pradesh Late Shri Krishna Kant who got absorbed in VP Sectt as Caretaker in Under Secretary level. **Under which Special circumstances, this Caretaker has been given Three (3) promotions that to being in ex-cadre post ?**

At a time, when Government of India is emphasizing on minimizing financial burden and cutting expenditure in each area, what is the reason of such huge financial expenditure on Vice President Sectt. Expecting an immediate response.
