Subject: Officers performing current duties of a Post-reg.

Sir,

I would like to bring it to your kind notice that as per the provision of Rule 12(2) of CCS (CCA) Rules, 1965 an officer appointed to perform the current duties of an appointment can exercise administrative or financial power vested in the full-fledged incumbent of the post but he cannot exercise statutory powers, whether those powers are derived direct from an Act of Parliament (e.g. Income Tax Act) or Rules, Regulations and Bye-Laws made under various Articles of the Constitutions (e.g. Fundamental Rules, Classification, Control and Appeal Rules, Civil Service Regulations, Delegation of Financial Powers Rules etc.). The Vice Chancellors who are performing the duties of acting Vice Chancellor in their respective Central Universities may take note of the above provision of CCS (CCA) Rules 1965 and refrain from taking any action in contravention of the said provision.
