Sir/Madam,

I am the counsel for my client Mr.T.Boobalan, S/o Mr.Thiruneelselvan, who have filed a Criminal Original Petition 25904 Of 2015 (pending on the file of High Court of Madras) which is related to that of trafficking of six women from Tamil Nadu towards Kuwait.

The above mentioned case has come up for hearing before the high court of madras on:26/04/2017 and on that day the court asked me orally to file the information of statistics related to the violations on migration of Tamil Nadu Workers to Kuwait and other Gulf countries, before the next hearing on 8 June 2017. Hence, I request you to kindly provide the information under Section 7(1) of the RTI Act within two days, as the matter is concerned of the life and liberty of six women:

- 1) How many complaints were pending on the trafficking of persons from Tamil Nadu towards Gulf countries, for the purpose of exploitation in the disguise on foreign employment by the registered and unregistered Recruiting Agents, which is punishable u/section 370 of IPC?
 - a. Mention the Name and contact details of the alleged traffickers registered and unregistered Recruiting Agents?
- 2) How many complaints were pending on the trafficking of persons from Tamil Nadu towards the State of Kuwait, for the purpose of exploitation in the disguise on foreign employment by the registered and unregistered Recruiting Agents, which is punishable u/section 370 of IPC?
 - a. Mention the Name and contact details of the alleged traffickers registered and unregistered Recruiting Agents?
- 3) How many complaints were pending before the Office of Commissionerate for Rehabilitation and Welfare of Non Resident Tamils on the below issues:
