SUB:- COMPLAINT WHICH IS HIGHLY SHAMEFUL TO THE ACCREDITED SATHYA MEVA JEYETHE LAW JUSTICE (ASLU) OF THE COUNTRY & WORLD, REGARDING THE WILLFUL MALTREATMENT AND ILLEGAL DRAGGING OF THE LOAN DISPUTE MATTER OF THE INNOCENT JUDICIAL REFUGEE ACCUSED IN THE CRIMINAL LITIGATIONS WITH THREE BANKS' LOAN DISPUTES (WHICH WILLFULLY CREATED LOAN DISPUTES STARTED FROM THE YEAR 1999) BY THE PRACTICE OF THE MCLJ OF THE SKD OF (BM&S) BY THE GEL & THE BANKS WHO ARE ^{BY THE GEL & BANKS} ~~AKIN~~ ^{AKIN} BM&S KAVRAVAS.

It is humbly submitted that I received a Hindi reply from the usually English speaking FM minister of MOF F.No.12/1/2017 Dt:09/05/2017 & the reply of Vice H.E. VPS/R-31.03.2017/US DT: 31st March 2017 and the both are Xeroxed with this complaint for analysis & due action by the authorities of India with the underlying note that this step would have done when the ^{then} H.E. initiated ASLU in the year 2008. Further, In regard to that, irrespective of the legal validity of the content of the reply by the FM, what I have already submitted for decade is that in the willfully created NPA loan accounts ^{By the GEL & Banks} for some mysterious devilish interests, they (=the GEL & the Banks) have not heard or yielded to any of my ASLU (= India's Constitution guaranteed & Accredited "Sathya Meva Jeyethe" Law Justice) decade old steps instead, for achieving the said devilish ends, they followed all the secret steps in accordance with the MCLJ (Mysterious Cheating Law justice) of the skd (shit "kutty=little" devil) of BM&S (Black Magic & Shamanism) and therefore, they (who know very well about their ^{own preplanned} willful serious criminal illegalities done against the ASLU & against me as per my already complained in the 55 + criminal illegalities/22 cheatings done by them) only know how to settle the loan disputes in accordance with the ASLU of India and I have already given my consent for such ASLU settlement of the loan disputes decade ago and in that regard, any authority who draws the salary of the country, can do it without any fear as he needn't fear to act in accordance with the ASLU and that is what our former brave Hon'ble Lady President of India fearlessly ^{in my loan disputes} did to develop an ever holy "Sare Jehamse Acha Land of "Sathya Meva Jeyethe" for the sincere & holy worship of the Cow Gods of India". Since I believe in "Truth & Justice" and on which, I have already given my consent that the said willfully ^{or so} created disputed matters by the GEL & the banks, once settled in accordance with the ASLU, I will not rush with an appeal to an Appellate authority and further in that regard, it is legally or even otherwise immaterial whether the disputes are settled in my presence or absence as long as the principles of the ASLU is applied to settle the willfully created loan Account disputes. Though, this most humble way of settlement suggested decade ago by me, it is not known why the MOF is keep on sending irrelevant BM&S replies and which replies can only drag the decade old matter further & further as per the "red-tapism ritual of the skd" to exactly go in line with the order of the "Judicial Refugee" (=JR) status ^{by} of the HC Bench at Jaipur WPC 14146/10 Dt: 20/12/10 and the same was the situation of the ASLU binding JR Pandavas of Mahabarat epic to send them to forest to live there in accordance with the MCLJ of the skd of cheating Kauravas and in that regard, the whole mistakes of the loan account disputes ^{were} from the irresponsible MOF who is functioning only for carrying out the skd rituals of "Eating, Shitting, Cheating & insulting the Constitutional Lady Head of India BY THE MOST HORRIBLE SHIT STORY in retaliation for THE H.E.'S moving India in accordance with it's ingrained ASLU for a "Sare Jehamse Acha Land of "Sathya Meva Jeyethe" for the sincere & holy worship of the Cow Gods of India" and It is further submitted that the inevitable/inescapable punishment for it, will also be in accordance with the warning advice of our PM & former HM of Kerala that "BURAI KA PEOPLE WILL HAVE TO BE PERISHED/RUINED OR WHOEVER INGESTS SALT WILL HAVE TO DRINK WATER IF NOT TODAY, AT THE MOST BY TOMORROW and which true justifiable verdict though, I frequently remind the GEL & the banks for years, is yet again proved correct in the sinful activities of a "Saffron-clad rapist of TVPM who got fitting Moksha" as per the TOI in accordance with the sins he committed and
