Application for Enquiry & Justice in a

"Thulla" type activity, I:e "Dalal & Dalali" or "Agent & Commission" (Benefit) Act, between DOPT & AIIMS ENT Board, by " Oral" "Verbal " settings.

Exposing "**Scandal**" of getting illegal work done, apparently appearing as 'Genuine & Legal', **by " Oral" "Verbal " settings** (Mutual Beneficial Instructions) for Extra Official Intrests (Corruption) between **DOPT & AIIMS ENT Board.**

Because:

Against below mentioned illegal acts on the Part of AIIMS ENT Board, we filed various seprate & Periodic complaint applications, for enquiry & action, but got reply from AIIMS ENT Head of the Dept., Dr. Shri Suresh Sharma wide letter dated 27/10/2016, that, **"An enquiry was conducted in our complaints & did not find anything inappropriate in evaluation & / or preparing the reports etc. .**

However, when details of the said Enquiry like, Records & Proceedings, office Notes & final Disposal of Enquiry proceedings were requested under RTI, we received Shocking reply dated 18/01/2017 received by us on 30/01/2017 as :

That " Prof. S.C. Sharma, Head Of The Department, has discussed "Verbally" with Board" & Docxtors & there is "no record" of proceedings.

Infering:

There is no enquiry Conducted & by acts of Oral Settlement among themselves as above (AIIMS & DOPT), we are told that
