Sub: Registration of F.I.R against Mr. Balwinder Singh (a) lovely R/o flat no. B-9 Saket and Mr. S.S.Jaspal R/o C-96, Eastern Avenue Sainik Farms N.D-62.

I Piu Chakraborty w/o Sh. Raj Chakraborty am a resident of C-175 Jahwar Park Devli Khanpur New Delhi Ph.: 9717483036, 9555655676. My husband worked with M/s Gurukul Export as Production Manager at Western Avenue Sainik Farm New Delhi from June 2009. In the year 2009 the said Company Provided accommodation to us at D-138 Krishna Park, First Floor Devli Khanpur. Sh. S.S.Jaspal(Ph.: 9810040131, 9810454586, 9810198709) the owner the company and his nephew Mr. Balwinder Singh @ lovely started visiting our house along with my husband off and on. We celebrated the birthday of our daughter on 11/07/2010 which was attended by Mr. Balwinder Singh. After the ceremony, he sent a message to me expressing his love for me which I did not like it and ignored it too....

That in the month of Dec. 2009 the said Mr. lovely raped me and warned me not to report to anyone. He also told me that he has good connection with Police and other departments. I did not like what he did until his boss Mr. Jaspal visited my residence to discuss this subject. Mr Jaspal assured me that if I leave my husband he will get me married with his nephew Mr. lovely who raped me. He also told me about his contacts with powerful officials. He further informed me that they have the video clippings of the rape and other nudities and will expose me, so I got frightened and kept quite. My husband came to know about the rape from the wife of Mr. Lovely the person who raped me. I had no other choice but to explain everything to my husband on 01/11/2011 and thereafter my husband left me alone due to the said illegal act, and in the meanwhile Mr. Lovely and Mr. Jaspal started ignoring me and threatened me. Getting lonely and depressed I was left with no alternative but to Consume Poison and commit SUICIDE. But at that time somehow my husband came to know about it and took me for treatment and I was admitted for two days at Safderjung Hospital New Delhi. Mr. Jaspal got the records of my treatment destroyed to save his skin, with high contacts.

On 07/11/2011 I lodged a formal complaint with Neb Sarai Police Station which was received by them only on 19/11/2011 vide Complaint no. 34B (Photocopy Enclosed) and because of high contacts and money power of the accused no action was taken against them as Mr. Lovely had been claiming that his brother-in-law is an IPS officer in Rajasthan and Mr. Jaspal had been claiming that his Co-brother was D.G.P Maharashtra. When all my efforts to get an F.I.R failed I represented to D.C.P South and Commissioner of Police, ultimately I had to move Hon'ble Supreme Court Of India to get justice who in turn vide their orders dated 27/02/2012 (Photocopy Enclosed) issued notices to the concerned parties. I also got the case registered with the National Commission for Woman New Delhi on 06/03/2012 who have been taking the help of an N.G.O "Prayas" but still they failed to get an F.I.R registered because of clout of Mr. Jaspal in the Administration and his money power.

As I was getting constant threatening calls (which are recorded) from both the accused that they will make my video clippings public and will liquidate me, so I met them on 06/04/2012 to get back my video clippings but they did not deliver the same to me and called me again on 07/04/2012. On that night I was again taken by them to B-9 Saket. Mr. Jaspal told me you can't do anything to us and it will dangerous for your life. Mr. Lovely again raped me with all the threats and snatching of my both phones and did not allow me to make any calls. On 08/04/2012 at the first available opportunity I made a complaint at 100 no. and went to Saket Police Station to lodge a complaint alongwith a Social Worker Ms. Saroj Verma (Ph.: 9818427770). Policeman on duty Mr. Upender heard the entire case and Contacted the SHO/ACP over telephone and intarrogated me fully well and put us off with the instructions to come back the next day only because they knew very well both the accused persons. Then I again went there alongwith a Social Worker Mr. Manoj Bhalla (Ph.: 9958116786) and insisted for lodging a complaint and Registration of F.I.R. After lot of arguments he agreed to take a complaint which was written by myself as complaint no. 56B (Photocopy Enclosed) and Mr. Upender had all along been interfering with the contents. During this he misbehaved with Mr. Manoj Bhalla and shunted him out. So while my complaint was being recorded followed by my statement recorded by Mr. Upender himself it was night time, there was no

or POLICE Officer and the Social Worker accompaining me was also shunted out. This all illegal act was one because of Clouts of the Criminals in the Police Station. Mr. Upender confirmed the facts from P.C.O about the call made by Mr. Lovely to me. They also confirmed from Barista Coffee House about our visits on both the dates and called for the video recordings. Thereafter they called the guard of B-9 Saket flat who also confirmed these things and the incidents at the instructions of Mr. Jaspal. Then he talked to Mr. Jaspal on phone who confirmed the facts but refused to give the phone no. of Mr. Lovely. He did not call Mr. Jaspal to the Police Station. Thereafter a lady police officer was called and they sent me for Medical Examination where in Rape and Scratches on my private organs were confirmed. But instead of Registration of F.I.R and arresting the culprits they asked me to come to Police Station the next day. On 09/04/2012 they had been interrogating me all alone as if I was the Culprit and dictated me to write a request asking for two days time for reconciliation which was totally illegal. Rather the S.H.O should have registered an F.I.R and arrested the culprits. Still during these two days also I tried my best to get back my illegal video clippings but all along I was getting threats from the Criminals as Police was with them. After two days I again visited the Police Station for getting the F.I.R registered but was put off on one ground or the other and this continued. Instead of registering an F.I.R. to gain the time S.H.O referred the case for legal opinion. By that time further Medical Reports had also come from Rohini Lab confirming the Rape. Legal opinion also confirmed the Rape and recommended for registration of an F.I.R but still S.H.O did not register it and again sent it for re-consideration of the Legal Section only to gain time and give relief to the criminals. Till date I have been regularly visiting the Police Station atleast 20-25 times and result is the same i.e. Delhi Police is for the Criminals. When so ever I make a call to the Police Station to enquire bout the Progress they asked me to come to the police station personally. Instead of relying on the statements of the victim, which is my legal right they have been interrogating & interrogating and demoralising me. Mr. Jaspal has not been called even a single time to the Police Station to discuss about my videoclippings with him etc.etc..

The Police has been claiming that this was a Live in Relationship but there was nothing like that and it was an Induced and threatened Rape by Mr. Lovely with the promise to get me married with Mr. Lovely which they did not, and also didn't return my vedio clippings. Second plea being taken by the Police is that I had been doing it all for grabbing the Property of Mr. Lovely. But this is also not true as Mr. Lovely does not own any property at all and his parents have already disowned him. Had I been after the property I would not have taken the extreme step of Consuming Poison and commit suicide.

A photocopy of the Public Complaint Dt.: 28/04/2012, showing as to how much crook these criminals are and Mr. Jaspal has been claiming himself to be a DON of Delhi is already with your goodself, for your Honour perusal pl.

You are therefore requested to intervene and get an F.I.R registered against Mr. Balwinder Singh Walia @ Lovely and Mr. S.S.Jaspal, who are influential criminals with a bad history, for Blackmailing, Trespass, Threats, Fraud, Cheating, Abduction, Kidnapping, Criminal Breach of Trust, Criminal Conspiracy, Outraging the Modesty of a Woman, Inducement, Rape, Harassment, Tortures, Abetment to Suicide, Destruction of Evidence, Illegal Video Recordings etc. etc.. and proceed against them as per the law of the Land.
