SUB:- Complaint which is highly Shameful to the GEL of the country, regarding its willful maltreatment and illegal dragging of the loan dispute matter of the innocent accused with three banks which started from the year 1999. This 28 page complaint may be incorporated with the earlier sent 28 page complaint with IPO/Court fee stamp of Rs.10/- (for the RTI Act reply) dated 29/6/16 by registered post to the (18 authorities) H.E., Vice H.E., PM, CJI, PM of India, ACJ of Kerala, DGP of Kerala, DRT Ekm, involved 3 banks, DJ, CJM, JFCM-3 TSR, Dt. Legal Cell Authority, District Collector TSR, Press Club & Advocates' Bar Association of Thrissur, and this 28 page complaint includes the earlier one's first 18 pages of Dt. 29/6/16 along with their proof of service (18 IP receipts).

To, H.E. Muhammed Hamid Ansari, The Honble Vice President of India 11/06/11
It is respectfully submitted that the illegal possession of my movable properties by the federal bank, Vatanapiily from the date 16/3/2009 can't be possessed by me due to the following reasons; 1. Both the movable and the immovable properties were possessed by the federal bank with the help of an invalid order from the HC Kerala WPC 5474/09 and the legal validity of the said order was questioned/challenged by the CRL Appellate Authority of Bombay HC Bench at Aurangabad through its order WP CRL 513/2010 and the same challenging order WP CRL 513/10 was submitted to all the authorities innumerable number of times by me for its proper treatment and correction of the wrong legal steps taken by the bank and the KCD GEL and which included even in the criminal matter MC CR 1844/14 KHC, but in vain due to the willful lack of interest of the banks and the GEL by their being strongly addicted to the cheating KCD and thereby, to cheat and destroy the country's accredited principle of "Sathya meva jeyethe" which is glaringly exhibited in front of them to show the litigants and the people of the country. 2. It is not known under what circumstances or legal support, the bank held the properties which included even a criminal property, a car with an NPA loan of another bank for almost 8 years (from 16th March 2009) in a simple loan A/C dispute despite my innumerable attempts to settle it not only through the involved banks but even through the GEL and Media. It is a shame for law, not only of India but even of the world to hold the properties of the borrower without any reason as well as against the innumerable legitimate complaints of the owner of the properties to the extent of their properties destruction due to their prolonged disuse. What is their use for me after 8 years of their disuse? 3. The bank illegally possessed and held illegally a new car with NPA loan from another bank (Corporation Bank, Thrissur) and despite my innumerable complaints to settle that NPA loan, the illegal ^{and} possessor, the federal bank and the loan advanced Corporation bank and along with the GEL didn't do any legitimate action on that thereby, proving the earlier stated true picture of Indian Law that "one country with two laws akin one snake with two heads" and in that, the GEL was quick in action (which ^{was} even by FAX message at 0700hrs on 16/3/2009) to realize the due amount of the NPA housing loan of the federal bank and the root cause of the said loan to become NPA is by the federal bank himself due to its willful mistakes in order to grab the precious property of the borrower at a cheap rate by creating willful mistakes in the loan A/C while the bank and the GEL is totally silent on the NPA car loan despite its well knowledge available with the banks and all the authorities by my innumerable complaints in that regard. 4. Similar is the situation with the Canara Bank and in which, I stated twice (on two sittings) before the civil law court of Thrissur when I was summoned (to give clarification about the 5 year term NPA computer loan of the year 1999) in reply to that I stated the true situation about the illegal possession of my properties by the federal bank and in which included the cheating documents and lawyer notice along with details of the loan A/C showing the stated irregularities of the Canara bank about its excess amount taken to that of the due amount. 5. Since my children and I am god fearing people and attempting truthfully and sincerely to lead "the way, truth and life of Jesus Christ", prolonged disuse storage of the properties connected with the Kutty Chatan Devil (KCD) destructive rituals (such as "Black magic, Shamanism and other billions of such ones which included the firing of flatus in the public causing nightmare stampede, Epic Shit
