

Respected Sir,

I the above mentioned humbly request your good self to kindly furnish me the following information under the Right to Information Act, 2005:-

- 1) During the process of Direct Recruitments in Government establishments, applications are invited under the "General category" (Unreserved Category) (13 posts) and under "Other Backward Class category" (Reserved Category) (03 posts). In the above case please provide the following information:-
 - a) Besides the selection of the 03 posts in the Other Backward Class category as per the requirement, can an additional candidate who has applied under the Other Backward Class category be adjusted in the General category on the basis of Merit? Please provide a relevant certified document in either of the cases (i.e. Yes or No)
 - b) Can a candidate belonging to the Schedule Caste or Schedule Tribe apply under the General category and if selected on merit basis be adjusted in the General category and thereafter enjoy the benefits of the Reserved category? Please provide a relevant certified document in either of the cases (i.e. Yes or No)
- 2) During the process of Direct Recruitments in Government establishments, can the objective type written examination answered by the candidates in HB pencils as per the instructions on the Question Paper conducted by the UPSC or SSC or Concerned authority be considered as genuine and authentic? Please provide a relevant certified document in either of the cases (i.e. Yes or No)

- 3) Can an individual who is a citizen of India, under the Right to Information Act, 2005 apply to any Government establishment and request them to furnish the Question Paper(s) and/or the Answer Paper(s) of any written examination held for Direct Recruitments for a particular post and is the concerned department bound to furnish the same? Please provide a relevant certified document in either of the cases (i.e. Yes or No)
- 4) The list of communities belonging to the "Schedule Caste, Schedule Tribes and Other Backward Class" (Reserved Category) in the State of Goa, Karnataka and Maharashtra.
- 5) The Term or Duration of period a selected candidate or an employee of a Government establishment is eligible for his/her promotion belonging to the General, Schedule Caste, Schedule Tribe & Other Backward Class category. Please provide a relevant certified document in context to the same.
- 6) The requisite fees of Rs.:10/- (Rupees Ten only) has been paid in the form of Indian Postal Order No. 97E 710764, dated:13-06-2013. Please find attached herewith the same for your kind reference.
- 7) Any other necessary fees/charges pertaining to the information sought shall be paid upon your intimation.

I humbly request your good self to kindly provide me the certified copies of all the necessary documents sought.
