My wishes to Hon. Prime Minister and his Administration. I am a Voter and Pensioner. This is 3rd reminder of mine. Honorable Parliaments are to render justice to its employees of Predecessors and Successors also without partiality.

I am a pensioner of CTRI (ICAR) under PPO No.3692. I received pensionary benefits upto 31.12.2015 of VIth CPC without tail. Government announced VIIth CPC with implementation from 01.01.2016.

Eventhough 15 months passed, VIIth CPC benefits are in untouchable distance for me: More over the Senior Finance and Accounts Officer (Pension) of ICAR informed me that orders of Govt. not received vide his letter dt. 21.02.2017 and 27.03.2017 copy enclosed.
