Misguidance by Ms. Jayaprabha Ravindran, Assistant Director of Archives (Research Room). National Archives of India (NAI), Janpath Road, New Delhi.

Respected Sir,

I wish to inform you that Dr. Pramod Mehra who was the Assistant Director of Research Room, National Archives of India and Ms. Jayaprabha Ravindaran who was Section-in-Charge of Research Room now Assistant Director of Research Room, both were supervisor of my Research work. Dr. Pramod Mehra had certified my research work of one year and ordered for payment for the same to the Government of Meghalaya but they did not make the payment. Later on, I demanded my due payments of Rs.2,62,000/- (Rupees two lakhs sixty-two thousand only) from the Govt. of Meghalaya, after 15 months the Government of Meghalaya issued the letter of termination of my contract with retrospective date i.e. with 15 months back date. The letter of termination was sent to Ms. Jayaprabha Ravindran, Assistant Director.

2. I would like to bring to your kind notice that my termination was instigated at the behest of the following officials of the National Archives of India:

- (11) Ms. Babli Parween, Daily-wager, now PA to DG.
- (12) Shri Pawan Kumar Kalia, Official in Secretary Office, Ministry of Culture, Shastri Bhawna

- (14) Prof. K.C. Yadav, Director, HIPA, Gurgaon

3. I would also like to inform you that as per the order dated 09.12.2011, Shri Rajmani, Smt. Jayaprabha Ravindran and Smt. Pranjana Singh were relieved for posting at Jaipur, Puduchery & Bhopal, respectively, but still the order has not been taken into compliance and their continuity at the NAI, New Delhi is not only causing problems, but loss to the SC/ST officials of NAI. Apart from this, the Research Scholars are also being harassed by these three officials and they are in the habit of unlawfully canceling the registration of research scholars. These three were also instrumental in the harassment and non-payment of dues of the undersigned.

4. In view of position stated in the preceding paras, I most humbly submit that these people must be immediately asked to proceed to join their duties in the respect stations of posting as it will be good for the NAI as well as other employees and Research Scholars. These three as well as other people involved in my harassment must also be punished stringently.

5. I also bring to your kind notice that you had sought the information vide your letter No.VPS-18/Rep/2012 dated 7th December, 2012 (copy enclosed) from the Chief Secretary regarding the non-payment of my dues amounting to Rs.2,62,000/- and to say that nothing has been received by me till date with compensation and I have also lost my energy in running from pillar to post, valuable time, post and mental peace.

6. I have also to mention that I had written a letter dated 5.12.2012 to Hon'ble Vice President of India to nominate me to any of the following posts:-

- (1) Governor of any small State.
- (2) Ambassador to any small country.
- (3) Chairman & Director, Minority Cell (Shastri Bhawan)
- (4) Director. of Minority Languages and Departments in University Grants Commission.
- (5) Director, National Council for Promotion of Urdu Languages.

7. I once again pray your goodself to bring the above to the notice of Hon'ble Vice President Sir to discuss the matter with Hon'ble Smt. Sonia Gandhiji, Hon'ble President & Prime Minister for getting the undersigned a suitable position as requested above.

8. I once again request your good-self to direct the NAI and the Government of Meghalaya to pay my legitimate dues as it is causing a hardship for me and also transfer the erring staff members of NAI as indicated in my letter.

9. I am enclosing a Postal Order No.08F 707832 for Rs.10/- for filing the RTI application.
