FOLLOWING POINTS ON THE SUBJECTS TO BE CLARIFIED TO THE HOLDING CHAIR PERSONNELS OF THE MANDAL COMMISSION COMMITTEE AS A CITIZEN OF AN INDIAN, A MEMBER OF SERVANT IN INDIAN GOVERNMENT DEPARTMENT, (ATTACHED WITH THIS APPLICATION AS AADHAAR CARD NO 6893 4339 5857, ELECTION IDENTITY CARD NO IYE0551556).

ENROLLMENT IN A GOVERNMENT SECTORS EMPLOYMENT JOBS AND THEIR SERVING IN UPGRADED ON THEIR CARRIER PROMOTION FOR RESERVED SHEETS BY THE MANDAL COMMISSION.

QUESTION HOURS IS IN A INDIAN CITIZEN ON A GRIEVANCE OF A GOVERNMENT SECTORS EMPLOYMENTS / RECRUITMENTS / CARRIER UPGRADE PROMOTIONS.

1. WHY DOES NOT GIVEN THE PERCENTAGES OF BELONGS GENERAL CASTE PEOPLES QUOTAS/ RESERVED SHEETS IN A GOVERNMENT SECTORS EMPLOYMENTS PASSED BY THE MANDAL COMMISSION COMMITTEE.

THE MANDAL COMMISSION COMMITTEE IS PASSED ONLY BELONGS TO THE CASTE FOR SCHEDULED TRIBE (ST) -7.5 % , SCHEDULED CASTE (SC)-15%, OTHER BACK WARD CLASS(OBC)- 27% , REMAINING THE 50.5 % IS RESERVED FOR GENERAL SHEETS THAT MEANS ALL CASTE PEOPLES ARE ELIGIBLE, HERE THE GENERAL CASTE BELONGS PEOPLES RESERVED SHEETS QUOTAS ARE NOT MENTIONED/ GRANTED ACCORDING TO THE MANDAL COMMISSION POINTS OF SUBJECTS.

HOW MANY PERCENTAGES DIVIDED TO GIVES LIVING/ BELONGS OF THEIR NATIVES IN URBAN, RURAL, VILLAGES, REMOTE/ HILLY AREAS PEOPLES.

CAUSE: -

- a) ALL SECTORS IN A GOVERNMENT EMPLOYMENTS IS THEIR CARRIER UP GRADE PROMOTIONAL SHEETS MOSTLY HAVING THE EMPLOYEES BELONGS OF GENERAL CASTE PEOPLES,
- b) TILL DATE IS NOT FOLLOWED THE MANDAL COMMISSION COMMITTEE RESERVED SHEETS QUOTAS BELONGS THE ST, SC, OBC CASTE PEOPLES ON THEIR CARRIER SERVICE OF NEXT UPGRADE PROMOTIONAL S.
- c) TILL DATE, IS NOT GIVEN THE RESERVED SHEETS QUOTAS BELONGS THE PEOPLES OF OBC CASTE IN THEIR CARRIER SERVING NEXT UPGRADE POSTS ON PROMOTIONS AGAINST THE MANDAL COMMISSIONS RESERVED SHEETS.
- d) WHY DO NOT FOLLOW THE GROUP A IN A GOVERNMENT SECTORS EMPLOYMENTS ON THEIR CARRIER SERVING NEXT UPGRADES PROMOTION POSTS, PASSED BY THE MANDAL COMMISSION COMMITTEE.
