

Sir,
With reference to the subject cited above, I have the honour to state the fact that complaining of a Muddy Road, from Do'bu Rongmu to Bo'bu Chitimking via Rongtam River, Shri Jhondo Marak House, Shri Rikjang Marak's House The said culverts which is in front of Shri Rikjang Marak's House .Which has been constructed by Shri Kelbinath Marak, Secretary of VEC, Shri Sunath Momin, President of VEC, Shri. Exquil Sangma, Headman of VEC, along with the villagers.

That Sir, it is noted here that they have worked for 3 days instead of 6 day in a week and passed the bill for 6 (Six days) in a week, that sir, it is noted here that they have worked for 2 days instead of 6 day in a week and passed the bill for 6 days in week last year it is illegal in the eye of the law of the country and the present condition of the Road is deplorable to go on foot. Till today. And they are doing the work with material damage i/e soft stone like clay I therefore pray your prompt attention to this Road which is very much important to the Local people and school going children. In this regard. Villagers have not received their revised rate which has been fixed by the Government till to day where as B.D.O of Songsak, East Garo Hills, Meghalaya is also involving in this said activities.

I, therefore once again fervently request you to kindly check their maintenance of Job Card each and every House Hold. So that they can get their proper benefit in equal manner. It can be learnt from reliable sources that they have not received any material till now.

That Sir, it can be noted here that those corrupt officer will be removed immediately and bring good officers at an early date, I find that the B.D.O. Songsak and other B.D.O. may kindly pay to the workers under the minimum wages Act, 1948 and Compensation Act, 1923 under the said Act, and their Names, ages, Address, occupation will be recorded for want of various schemes otherwise villagers will not be developed by means of miss - appropriate fund.

This is for favour of information and necessary action.
