With reference to the subject cited above, I am the absolute owner of flat No. 2, on the Ground floor in Vaishnavi Apartment. My husband is working at Oman, and I am residing along with my minor daughter (aged 4 years) in the aforesaid address.

My husband and myself have purchased flat no. 2 constructed on site No. 50, situated at 4th Cross, Malleshwaram, Bengaluru for a valuable sale consideration vide sale deed dated 12/08/2016.

I state that I had complained to the BBMP authorities regarding the irregularities that are taking place in the flat ie., some of the occupants are using the flat for commercial purposes, besides illegal parking in the basement, aggrieved of the issuance of the notices to the BBMP authorities and for other best known reasons to the aforesaid persons, who attacked us with a common intention to defame and degrade us came to our house.

The aforesaid accused persons are highly influential persons, till date BBMP authorities though issued notices to them, have also not initiated any kind of action against them.

I state that we have a CC TV Camera installed since the past nearing 1 ½ years, which records each and every moment.

I state that on 13/01/2018 at around 2.20 to 2:30 pm, all the accused persons came to our Flat who assault me both physically as well as verbally.

Sri.Jaganath touched the body of **Mrs. Sumitha Pravin Bhanu** and pushed inside the room, who has man handled me. (the fact of which is recorded in CCTV)

All the aforesaid persons started insulting with abusive language to my husband and myself for no reason, the main intention and object of the aforesaid accused persons is to insult me and my husband in front of the public.

All the aforesaid persons narrated above used foul language by outraging the modesty of a woman along with gesture & intrudes upon the privacy of myself & my husband Sri. Pravin Bhanu.

Mr Jagannathan went upto the extent of saying that I am not a good lady and not staying with husband at Oman instead staying alone in Bengaluru as He said moving around doing prostitution business in the flat.

This type of attacking us is not the first of its kind, it has been repeated several times, as we live in civilized society, we thought that the aforesaid persons would get correct themselves, which proved out to be false.

I have a CCTV footage, which has the recording of the untoward incident that took place on 13/01/2018 at around 2.20 to 2:30 pm, The CD is herewith produced for your kind consideration.

Kindly take necessary action under the relevant provisions of IPC *IPC294, 354, 506, 509 r/w 34 IPC*

By the act of which I & my family members shall be highly obliged.

Kindly direct & instruct the jurisdictional police authorities ie., Malleshwaram Police Authorities ie., The Inspector, (Sri.Prasad) Malleshwaram Police Station, Bengaluru telephone number 08022942519, 9480801315 Website: www.ksp.gov.in to make necessary arrest / interrogation based on the FIR dated 14/1/2018 as well as initiate legal proceedings. Though FIR being lodged no arrests have been made.
