Sub: Enquiry made in respect of complaint regarding harassment and encroachment on my property.

Enquiry report of Sh. Tarak Nath Mukherjee, ASI dt. 14-8-2012.

Sir,

I have received the above letter from your office alongwith the report in reply to my petition which was made long back on 6/3/2012. I have been forwarded a Police enquiry made by the I.O. Sh. Tarak Nath Mukherjee, ASI-2020 of Ghatal P.S., Distt. MDP dt. 14-08-2012.

I hereby submit that report given by him is biased and far from the truth. Police is misleading the administration by giving false base of our leaving our village Ghola, P.O. Jaynagar, P.S. Ghatar, Distt. West Medinapur. It is wrong to say that we have taken huge amount of loan from the culprits as police has not even tried to produce evidence for their statement. In fact the true story is as under:

I further submit that I have been suffering from torture being given by my neighbour Saiyad Ulfat Hossain S/o Lt. Tahar Ali and his Group men of my Village Ghola for the last 11 years. For their torture I had to leave my house along with my family. Practically now I and my family passing our days in starvation though we have had sufficient property to maintain ourselves. Earlier two occasions they tried to burnt us alive and in that case we lost our dwelling house. Inspite of that they did not allow us to lodge complaint before Police Station or other administrative authority.

On 11.12.2001 Saiyad Ulfat Hossain and his party assaulted me and out-raged my modesty but police did not take any action against them on the contrary Police started a false case against me & my family as we did not agree to compromise the matter under the pressure or direction of the Police. Even Police did not allow us to incorporate the fact of burning our dwelling house by the above miscreants.

For the inaction of Police and also of the local administration I compelled to leave our house and bound to take shelter in my paternal house. Said miscreants forcefully grabbed our property in Plot No. 142, 165, 174 totaling 26 Decimals under Khatian No. 302 Mouja-Ghola and now cultivate the same. They also took forcible possession of our valuable property in Plot No. 149, under Khatian No. 270, Mouja-Ghola (J.L. No. 142) under Ghatal P.S. which is situated by the side of Pitch Road and now trying to make construction of the same.
