5. In case it is felt that the information sought pertains to personal information/third party information, the concerned Branch/Section may initiate action as provided under Section 10 and Section 11, under intimation to RTI Cell **within 3 days** from the date of the Note.

6. In case certain points of the application, marked to a particular Section, does not pertain to it, and , falls under/pertains to another Section/Branch then the same may also be intimated to RTI Cell **within 3 days** so as to reduce avoidable delays.
