Application under the Right to Information Act 2005 for obtaining information/reason of repeatedly arrest our family members including me with evidence of fact likes financial transaction of fund transfer and medical bill with report as well as jewellery bill referred to procedure of arrest were followed in investigation which case given by my wife who highly qualified Finance professional (MBA-Finance,BSC with math & Engineering studied in Salt lake Kolkata) after withdrawing 2.5 lacs from Joint A/c through self cheque which I have saved for spending in sister's marriage with this RTI a prayer petition on the grounds of Article 21 of CONSTITUTION OF INDIA with the provision of 21(B) in HINDU MARRIAGE ACT 1955 for personal liberty to save our family from multiplicity of proceedings & litigations since 2013 without following the due procedure dissolution of marriage and other torturing of monetary extortion related disputes which are the spirit of hindu marriage act like false 498a and attempt to murder case, SEC 125 CrPc Maintenance case based on fake information for harassment which case not possible to attain day to day court in other district though not intention to disobey court order by our family after recently sudden death of my father - pleads the impression of being forward to your lawful and constitutional way of consideration without your prompt interference not possible to get positive result because it's a constitutional process and it is well known Supreme Court of India has declared the misuse of 498A as legal terrorism- A failed marriage is not a crime, however, the provisions of Section 498A, 307 are being used to convert failed marriages into a crime and the people are using this tool to extract as much monetary benefit as possible.
