
Sir,

Subject: APPEAL FOR SEEKING JUSTICE FOR INVESTIGATION SUSPECTED OF SUICIDE OF MY SON RAM GOPAL, EMPLOYED AS CHARTED ACCOUNTANT WITH RELIANCE INDUSTRIES LIMITED, NAVI MUMBAI AND SEEMS A CONSPIRACY BETWEEN SOME PERSONS NAMELY HIS IN LAWS AND S.H.O NAVI MUMBAI, DEAD BODY RECOVERED ALLEGED ON 27.09.2009

Hon'ble Sir,

With due respect, I Satpal Gopal, Father of late Ram Gopal Resident of Ward No. 9, Main Bazar, VPO Handiaya, Tehsil and District Barnala (Punjab)am requesting to investigate the circumstance for suspected suicide of my Son Ram Gopal employed as Chartered Accountant with Reliance Industries Limited, Navi Mumbai and seeking for justice. The grounds of suspected murder of my late son are as under :-

- (1) That my son Ram Gopal was employed with Reliance Industries Ltd., Reliance Corporate Office/Park, Building No.5, First Floor, Ghanfoli, Navi Mumbai as a Chartered Accountant. He was well settled from this service and was earning handsome salary of Rs.50,000/- per month.
- (2) That my son Ram Gopal was married to a well educated woman namely Mrs Prince daughter of Shri Om Parkash Goyal Resident of H.No.19173, DAV College, Beebi Wala Road, Bathinda who employed in Excise & Taxation Office. Both are enjoying their married life and living together in a rented accommodation. They are blessed with a son about 3 and half years ago.
- (3) That during the first week of September 2009, my son Ram Gopal had sent his wife Mrs Prince to her in-laws Village Handiaya, Tehsil & District Barnala (Punjab) and my son Ram Gopal was followed her. She arrived in village Handiaya but her parents became furious and agonized due to reason that their daughter Prince was sent to her in-laws house alone only. Hence Om Parkash Goyal, father of Mrs. Prince continuously threatened to my son on Mobile/Phone, as to why their daughter was sent alone and he will see him and will face dire consequences for such thing and be ready for the result in the near future.

- (4) That due to continuous serious threatened my son Ram Gopal became worried and was not feeling well . Under that this some type of conspiracy my son Ram Gopal dead body was found flouting in a pond. On 27.09.2009, S.H.O P.S Navi Mumbai was informed that the body of your son was recovered volunteers of Aashirwad Society, Navi Mumbai and found suspected suicide, who then performed postmortem and handed over the body to me.
- (5) That at the time of handing over the dead body of my son, S.H.O Police Station Navi Mumbai was told that the rented room of your son where living has been sealed and locked up by the Police authorities and it will be opened in my presence only, after the dead related ceremonies/ Bhog ceremonies are over. Immediately after completing the Bhog ceremony, I and my younger son Sohan Lal, reached Navi Mumbai for bringing belonging of my late son and competing all other formalities and to found cause of death, if any from the room of my late son. It was surprising and shocked very heavy on reaching at Navi Mumbai after seeing that locks/sealing of the rented house of my late son was broken and all the luggage/belongings and other suspicious documents have been taken away by in-laws of my late son in our absence to omit the suspected murder proof. This action was done by Om Parkash (father-in law) and his party in collusion with the SHO, P.S Navi Mumbai and intentionally omitted every proof of suspected murder. Hence the intension of SHO, P.S Navi Mumbai and Om Parkash were clear and arose many of doubts .
- (6) That the conspiracy and involvement of SHO, P.S Navi Mumbai in disposing off/ stealing of belonging and omitting every proof of suspected murder/suicide of my late son have creates doubts. Sh. Om Parkash Goyal, father in law and also taken over Security amount of Rs.1,00,000/- (Rupees one lakh only) from the owner of house, deposited by my son, besides all other documents i.e account books/pass book/fixed deposited receipts etc and all other items/ documents were washed from laptop/computer with intentionally with a fear of legal complication in any later stage regarding suspected murder of my late son Ram Gopal.

(7) That SHO, P.S Navi Mumbai told me that his family/wife had taken away all these things, whereas as per my knowledge and confirmed from the sources , her father Om Parkash had conspired with the help of SHO, P.S Navi Mumbai who allowed to open/break the seal of the room of my son in our absence and without informing me. It could not be happened without the help of SHO, P.S Navi Mumbai. The behaviour and intention of Shri Om Parkash and SHO, P.S, Navi Mumbai always in doubt and never tried to co-operate with us. Hence I have in clear doubt over the conspiracy angle of Shri Om Parkash, and his daughter Prince and SHO, P.S Navi Mumbai which needs to be investigated in the interest of justice.

(8) That Shri Kuradi, SHO, PS Navi Mumbai had clearly involved in a murder of my son and thereafter intentionally helping Shri Om Parkash and his daughter. It is seen from the Post Mortem Report it is found that only formalities have been completed to safe guard the Om Parkash and her daughter Mrs Prince and SHO, P.S Navi Mumbai in our absence. The Police Authorities have obtained manipulated statements as pre plan from the other parties to safe guard Om Parkash and her daughter with the help of SHO, P.S Navi Mumbai.

9. That Om Parkash and her daughter have stolen with the help of SHO. P.S Navi Mumbai belonging along with Laptop and computer and Gold Jewelry costing to more than Rs.25,00,000/-

(10) In this connection I am enclosing following documents held with me :-

(a) A Photo Copy of Post Mortem report of my late son.

It is therefore requested, to investigate the Matter deeply and lodge a FIR against Sh. Om Parkash Goyal, Mrs Prince, wife of my son and Shri Kuradi, SHO. P.S Navi Mumbai and obtained remand from the Hon'ble Court to know actual facts of murder of my son Ram Gopal which was converted into suicide to safe guard their live . Please do the needful and hoping for justice.
