1. the first and foremost, we are strongly facing problem for hiking of prices without any consent from the public with regards to our daily needs of commodities in the market in Williamnagar as it is circulating in some parts in Garo Hills especially for local consumer of poor citizens.
2. Municipal Board take no interest in development in public places such as in market areas in super market, bus station, main Bazaar, which are totally rooted and shattered just like skin and bones (Williamnagar Bazaar).
3. The most wanted and needy affecting our civilians were the unfinished and lengthily pending Simsang River Bridge of Williamnagar Warima East Garo Hills.
4. The second important need, of Our Garo Hills is the Aerodrome at Bajack A'gal, Which is simply remain pending unfinished in laming parties which actually is not at all concern to any political parties if our development is concern, which is also priory important for our communication and transportation other than land transportation, especially, when in times of band, Strikes etc. in Assam. Mostly we are lack behind for our basic needs of commodities or other necessary needs, Which this Baljack A'gal Aerodrome might help somewhat of our citizen of Garo Hills, It is not all concern for parties to seek fame glory in saying this party and that party has brought out or developed that aerodrome.
