#### **ORDER**

This relates to the appeal dated 10.12.2024 filed by Ms Shafna A Y, on the grounds that the CPIO had not provided requisite information on his RTI application dated 28.11.2024.

- 2. The records related to the original application dated 28.11.2024 were called for and it is observed that the applicant had used the RTI platform to seek information related to stipend or refund for roller hockey skating state and national level competitions. Since, the information sought through the RTI application did not pertain to this Secretariat, The CPIO/Under Secretary, vide letter dated 04.12.2024 had provided NIL information.
- 3. Reference is invited to Section 2(f) of the RTI Act, 2005 which defines "information" as any **material** in any form, including records, documents, memos, emails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.
- 4. In the light of the present appeal filed by the appellant requesting for 'information' related to other Public Authority, it is reiterated that this Secretariat does not hold any relevant. information sought by the appellant through his RTI application and accordingly supplied NIL information.
- 5. The appellant may note that there is no obligation to transfer the RTI application received from educated persons by this Secretariat that pertain to other Departments as observe by the CIC in its Order (No. CIC/SA/A/2016/001483) dated 01.08.2016.
- 6. With the above observations, the appeal is disposed of without any further action.


