ORDER

This relates to the appeal No. VPSEC/A/E/23/00035 dated 13.11.2023 filed by Shri Atul Gupta (hereinafter referred to as the 'appellant') aggrieved with the reply provided by the CPIO on the alleged grounds of providing incomplete/misleading information. The appellant has prayed for the complete information on the points raised in his RTI application.

2. The records are called for and it is observed that the appellant, vide his RTI application No. VPSEC/R/E/23/00185 dated 01.11.2023, had sought information related to roles and responsibilities of the Vice-President of India as the Chancellor of Delhi University. He further requested for the status of the grievance filed with this Secretariat.

3. In the light of the present appeal, the following emerge with respect to points raised in the RTI application dated 01.11.2023:

Point No. 1 & 5: Section 2(f) of the RTI Act, 2005 defines "information" as any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.

The PIO is required to supply the 'material' in the form as held by or under the control of the public authority and is not required to do research on behalf of the citizen to deduce anything from the material and then supply it to him. It is reiterated that no further 'information' is held by this Secretariat to provide on these points. **Hence, the response given by the CPIO to the appellant is just.**

Point No. 2, 3 and 4: In the light of the attachment provided by the appellant, the CPIO of this Secretariat is hereby directed to provide suitable reply on these points as per the provisions of the RTI Act, within 3 working days of issuance of this Order.

The appeal is disposed of with the above observations and directions.






