9) Expected time of completion of the enquiry, in case underway, may be intimated.



Subject: Regarding immediate FIR registration under appropriate IPC sections against HC/ASI SHAHBIR SINGH Resident B-48, Adhyapak Nagar, Nangloi, Delhi-110041, reportedly posted in Crime and Railway Unit, Delhi Police for committing cognizable offence since January 2014

Sir,

The Lieutenant Governor of Delhi on 29.07.2022, the undersigned had made a complaint by email against the above policeman for getting prepared EWS card and taking ration from FPS since 2014 After regular persuasion, the serious issue has been verified/enquired into by the Food & Supply Department and a report has been sent in **the office of Hon'ble Prime Minister of India by Vigilance Department** and a copy of the break-up verified during enquiry has been procured by the undersigned and enclosed herewith for your kind perusal.

On perusal of the above data/break-up, your good self would find on unequivocal terms that Smt. Anita Yadav, wife of the above policeman with her husband and son has been taking advantage of the EWS Card since the year 2014 and getting ration from the FPS shop. Surprisingly, the ANNUAL INCOME OF THE FAMILY HAS BEEN SHOWN as Rs.48,000/- (Forty-Eight thousand only). **four thousand rupees per month only** As per Break up the ELIGIBILITY OF taking ration from FPS of HC/ASI SHAHBIR SINGH and his son Jatin Yadav has also been shown. The report of the Vigilance Department has proved that the ANNUAL INCOME OF ABOVE POLICEMAN IS Rs.48000/- ONLY.

The other mind-blowing aspect of being further considered is that just after filing the complaint by the undersigned on **29.07.2022, on 01.08.2022, that process has completed very quickly in a record time within just (59) minutes with the convenience of collusion of officials the law-breakers instantly surrendered their Economically Weaker Sections ration card to escape from the law & criminality.**

It abundantly proves that the entire family including the above policeman intentionally, purposely & with some oblique motives and in collusion with each other indulged themselves in criminality combined with cognizable offences since 2014 and when someone tried to unfold them, they immediately surrendered the card.

Needless to mention that on the basis of documentary evidence received from the government department (concerned Food & Supply Department) after verifying the facts by the Vigilance Unit and sent to the office of the Hon'ble Prime Minister of India, no iota of doubt remains that the above entire family under the close supervision above policeman has committed the cognizable offence of forgery & cheating since long by submitting forged declarations of annual income as Rs.48,000/- and in furtherance of that taking ration from FPS for the past 08 years and by virtue of it are liable to be dealt with legally under appropriate sections of the Indian Penal Code with immediate arrest.

It is, therefore, requested that keeping in view the gravity of the offence, immediately FIR under appropriate sections of IPC may please be registered against HC/ASI SHAHBIR SINGH, his wife and son under the provision of section 154 Cr.P.C. and oblige.


