This is regarding promotion of Shri Mokhtian Singh, ACA (Reid) in the grade of Senior Time Scale (S.IN)

- The brief facts of the case is as under;-
 - (i) Shri Mukhtiar Singh, ICAS of 2002 was in the consideration zone for promotion to STS during the panel year 2006-07. The DPC was held on 14.07.2006 to consider the promotion of 2002 batch officers to the grade of STS. A copy of DPC's recommendations is enclosed. DPC was declared Shri Mukhtiar Singh as fit. Prior to the convening of the DPC Shri Mukhtiar Singh had refired on superannuation 30.04.2006. As such he could not be promoted to the grade of STS in terms of para 17.10 of G.I., Depti. of Per. & trg. O.M. No. 22011/8/87-Estt. (D) dated 09.04.1996. It stipulates that promotion of officers included in the panel would be regular from the date of validity of the panel or the date of their actual promotion, whichever is later.
 - (ii) NCSC had written a letter dated 17.07.2013 to this office and stated that Hon'ble Vice-Chairman, Dr. Rajkumar Verka of the Commission has desired that a clarification might be sought from the DoPT on the issues raised by the petitioner Shri Mukhtiar Singh, Retd. Asst. Centroller of Accounts.
 - (iii) Accordingly, this office sent an ID note to DoPT dated 14.08.2013 for their comments. In response to this office ID note, DoPT had replied vide their ID note dated 16.08.2013 and stated that as provision of instructions issued by DoPT, the Dept. i.e. C/o CGA has followed accordingly. This office had sent a reply to NCSC on the basis of DoPT's reply:
 - (iv) After that, NCSC had fixed a meeting with Honfels Chairman on 21.10.2013. A meeting was held on 21.10.2013 before National Commission for SCs to discuss case of Mukhitiar Singh. The case was discussed. The Jt. CGA apprized that as per DoPT OM dated 12.10.1998, the petitioner cannot be promoted after retirement. He retired on 30.04.2006. The petitioner has intimated that the Hon'ble High Court in WP(C) 4699/2012 has already overruled the DoPT Om dated 12.10.1998 in a similar case. The Hon'ble Vice Chairman advised that if the Hon'ble High Court has given its judgment in the similar case, then the case of promotion of Shri Mukhtiar Singh may also be considered in a similar line. Action taken report may be submitted to the Commission within 15 days time.
- 3. In this regard, the petitioner has submitted a copy of the judgment delivered on 19.09.2012 by the Hon'ble High Court of Delhi in WP(C) 4699/2012 where High Court was directed to the Department that the petitioner's pay be fixed notionally and he be granted notional increments, if any, due till his retirement and he be also granted pensionary benefits in accord with the directions given in P.G. George's case (copy enclosed).

- 5. Shil Maichtiar Singh has anther submitted that the noting portions of Advice (A) Section, Department of Legal Affairs, Ministry Law & Justice, which was collected through RTI by Shri Singh vide DoPT's reply dated 14.10.2013, in the note of Addl. Solicitor general of India dated 18.10.2010, it stiputates that the judgment of the CAT has been confirmed by the High Court and the benefit of notional promotion was granted to a retired employee. Only by reesan of the fact that there is delay in convening the DPC, which was held much after his telliment. No fault can be attributed to the retired employee(viz.) the petitioner, because the delay was not attributable to him. If any similar person claims the benefit naturally such benefit has to be extended to such similarly situated person as well.
- The office of Controller General of Accounts, Deptt. of Expenditure, Ministry
 of Finance has been facing so many such types of cases and will be facing in future.
- 7. In view of above facts and in the light of advice of Hon'ble National Commission for Scheduled Castes, DoPT is requested to consider the case of Shri Mukhtiar Singh for his notional promotion after his retirement and also requested for modification of OIM dated 12.10.1998 and issued a general instructions to solve the such type of situations not only our Ministry but others Departments/Ministries also.

This issues with approval of Controller General of Accounts.
