Sir/ Madam,

Already myself and few other employees of Scott Christian College have raised complaints before the Investigation Officer/ Deputy Superintendent of Police for Vigilance & Anti Corruption Dept, Kanniyakumari Detachment to register FIR against the accused Mr. Byju Nizeth Paaul, Correspondent/ Secretary for the Government Aided Scott Christian (Autonomous) College, Nagercoil for forcibly collecting bribe by threat, in the form of compulsory Building Fund for several crores of rupees from the professors of the said College, with voice records and sufficient evidences forcing to pay Rs. 6,00,000/- per person. The Assistant Professors of the said college, who have refused to pay the bribe has been taken revenge by forbearing their Career Advancement Scheme (CAS) Promotions as per UGC Norms, by not signing the Proposals approved by the Screening Committee. Several complaints have been raised by the victimized Assistant Professors before the College Chairman, Rt. Rev. A. R. Chellaiah and other authorities under the Department of Higher Education and Directorate of Collegiate Education. So far, no action has been taken.

I have appeared before the office of the Deputy Superintendent of Police of Vigilance & Anti Corruption Dept, Kanniyakumari Detachment on 12.12.2023 for Enquiry and submitted a statement, which is enclosed herewith.







Mr. Byju Nizeth Paaul (PAN: ANYPB9878L) is a close aide of Mr. A. R. John Kingsley, IAS, a Madhya Pradesh Cadre, Where Mr. A. R. John Kingsley is a Share Holder at Sl No. 3 with 100 shares as on 31.03.2023, in the company, "Malaiyil Plantations Private Limited" [CIN: U01122TN2011PTC079685]. Further, Mr. A. R. John Kingsley has been invited as the Chief Guest to lay the foundation stone on 04.11.2020 at Scott Christian College for the said Building Project without proper permission from Government/ Nagercoil City Corporation for an estimate of Rs. 6 Crores.

As the accused Byju Nizeth Paaul is a close associate of the said IAS Officer, no action has been taken in this regard. Hence, myself and the members of Church of South India, Kanniyakumari Diocese has decided to conduct a protest before the District Collectorate, which is our Constitutional Right under Article 19(1)(c), insisting the the Investigation Officer of Vigilance & Anti Corruption Dept, Kanniyakumari Detachment under the provisions of Prevention of Corruption Act, 1988 and on the basis of the Order dated 27.04.2020 in Criminal Appeal No. 989/ 2018 passed by the Supreme Court of India, [Citation: SC (0417) 2020], on the case titled as State Of Gujarat Vs. Mansukhbhai
