- That M/S Kotak Mahindra Bank Ltd had made an application to the District Judges Angul, Odisha 759122 for execution of decree in suit/arbitration case no 36 56/2014 on the allegation of legal representative of M/S Kotak Mahindra Bank Ltd, Regd office at 27,BKC, C-27, G-Block, Bandra kural complex, Bandra (E) Mumbai 40051 and branch office at plot no 184 Kedarsonr plaza, unit III, Kharavella Nagara Bhubaneswar, Dist-Khurda, Odisha 751001.
- 2. That the said loanee Mr. Santosh Kumar Behera and Branch Incharge of M/S Kotak Mahindra Bank Ltd, Branch office at plot no 184, Ground floor Janapath, Kedarson Plaza, Kharavella Nagar, Bhubaneswar, Dist- Khurda, Odisha 751001, made, forgery of documents and made me Guarantor. I had never gone to the said bank or furnished any documents of the said bank and even I do not know the said loanee Mr. Santos

any documents of the said bank and even I do not know the said loanee Mr. Santos Kumar Behera and the said official of the said bank and never visit any branch or office of the said bank.

- 3. By collecting my document and signed my forgery signature of mine the said person took loan for vehicle with the help of the concerned bank official.
- 4. Now the M/S kotak Mahindra Bank PlotNo-184, Ground Floor, Janapath, Kendrason Plaza, Kharavella Nagar, Bhubaneswar, Dist-Khurda, Odisha, Pin-751001 file a case against me for recovery of loan amount of Mr. Santosh Kumar Behera whose address given in the subject of letter by making me as guarantor of the said loanee.
- 5. This is totally forged matter case. I had never signed any documents of the said bank or know anything about the said loan and loanee. The said bank staff and the loanee took the loan by taking me as guarantor for the said loan and I don't know anything about the loan matter and personnel of the bank and loanee.
- 6. This is a fraud and cheating case and document forgedly prepared against me without my real signature and knowledge. I enclosed the copy of the said notice of the court from this notice. I came to know about the forged matter of the Bank and the said Santosh Kumar Behera the master mind as the forgery was made for his interest.

In view of this I pray you to examine the matter as per merit & rule and issue necessary order against the said accused person and provide me relief from this false case and take legal action for committing of forgery and a line in reply is requested.
