2. In this regard, the point-wise 'information', as defined under Section 2(f) of the RTI Act, 2005 is provided as under:


Point No. 1 to 3: No information is available in this Secretariat to supply on these points.

4. Any official responses or communications from the Vice-President's Secretariat to representations made by individuals, organizations, or the diaspora itself regarding the above issues.
