Sub: All my complaint letters turn to injustice, neglected and hidden police reports are always hopeless and useless, referred by you at my local police station.

Respected Sir,

With humble submission I would like to draw your kind attention to state that since many years I used to write petitions, letters to higher rank and lower rank administrative circles, as like President of India, Prime Minister of India, Home Minister of India etc., W.B. State Government, Chief Minister of W.B., Police Commissioner, Local Police Station and other level but every documents and letters always referred to local police station. They called me there, asked questions then advised me you may submit any letter or documents to anywhere, last of all that will return to our hand and we are the final decision maker. So I don't know what to do me for a proper justice. My concept all my complaint letters thrown into dustbin. No benefits gained for that; local police always injustice on me. I am a poor electrician. To prepare sending letters, a question of expenses money, times and labour. May open any solution through Human Rights Commission.

I am giving here shortly some hints about my previous and present complaint:-

- Missing my son My second son Prasenjit Shaw missing from this premises at the age of 16 years. Dt. 05.03.2002, Taltala P.S. missing G.D.E. No. 507 Dt. 05.03.02. No trace still today. I knock to legal way several times.
- 2. Theft at my house a big theft was happened at my house on 08.04.2011. Then we were absent and door was under lock and key. We moved for G.D. at Taltala P.S. Case No. 110 - 110 Dt. 09.04.2011 WS-380 IPC. The thieves stole my valuable materials

breaking our Almirah, Goods like Gold ornaments, silver ornaments, Copper coils and many things, our family ration cards also lost that time. Total value of the materials at about Nine (9) Lacks. We complaint several times to police and political leaders, went more places. But nothing rescued. Police were not active with their responsibility. Missing ration cards not even issued for our family members though I have applied many times and requested the officials.

3. Abnormal death of my elder son - There were a terrible attack on my elder son Late Surajit Shaw on 22.07.2013 by a gang of Gundas, the antisocials of leading party Trinamul when he was passing Rd. for home at night. They wounded, blooded, damaged whole-body of my son. From that incident my son had been suffering from various hard diseases, like heart, kidney, lungs, bone etc. He was under long treatment by private and government hospital, Medical College and Hospital, College Street, Kolkata, only outdoor treatment not admitted my son, the serious patient. They prescribed for long long days. Month after month, years after years passed by Hospitals neglected treatments. At last my son fall into sick bed forever. Once a day on 16.03.2019 suddenly he had been feeling seriously ill. I rushed to Medical College and Hospital, College Street, Kolkata. But emergency and outdoor was very busy. They refused to admit him. Time passed. The life of my son also gone under great suffer. Suddenly he came into unconscious and stopped his heartbeat forever on the grass and soil of Hospital's garden on 16.03.2019 at about 10-30 a.m. He was 39 years old. So by this way a death completed like a street dog. Is it humanity or civilization? But this is the state West Bengal and Trinomul government rulling the state. I also begged justice since 1978 for

various reason. Every time neglected my miserable story by State Government and police.

- 4. A forcible occupier It was a great blunder that I allowed a person Sk. Alauddin for a short stay of 15 days only, in one of my living room for a supervise his sick family member and medical treatment nearly hospital. He was recommended by the Caretaker of our Landlord Deb Kumar Paul. His name Rishikesh Das. I have done it only for humanity. The patient of Alauddin cured and died within 15 days. I reminded them to leave my living room. But they were not interested to leave my room. Since years after years Alauddin forcibly occupied my room still today. On the other hand they made false tenancy proof by the help of Chief Minister, Police and antisocials. I am paying rent all the 1st floor rooms. So how can they occupied and tenant of my living room? I complained against their activity to police and other higher level concern, several times. Like as Chief minister, Government of W.B., Police Commissioner etc. I am not owner of the house but tenant of the whole rooms of 1st floor and paying rent to the Rent Control Office.
- 5. Water line and privy The landlord Deb Kumar Paul disconnected my water supply connection since, 1995. I have to carry water from Bus Road for our daily use. Calcutta Corporation avoided my petitions and prayer.

  Our privy line also blocked by other shop keeper Prasanta Jaiswal at ground floor. No remedy open for me.

I am living here with my family an incredible life also miserable life. What would I have to do to get a right justice? It is a fact that all the incident happened by Trinomul antisocials.

So, I therefore praying to you please judge the upmentioned matters. I want to live a peaceful life before my death as I am now 80 years old. Not getting any support from Central Government or State Government. It is a question of humanity. I am waiting for your right observation and justice. Please do the needful at your earliest convenience.
