ORDER

This relates to the appeal dated 10.12.2024 filed by Shri Venkatesa Setty on the grounds that the CPIO had not provided requisite information on his RTI application dated 24.11.2024.

2. 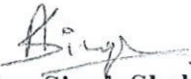

Reference is invited to Section 2(f) of the RTI Act, 2005 which defines "information" as any **material** in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.

4. In the light of the present appeal filed by the appellant requesting for 'information' related to other Public Authority, it is reiterated that this Secretariat does not hold any relevant information sought by the appellant through his RTI application and accordingly supplied NIL information.

5. The appellant may note that there is no obligation to transfer the RTI application received from educated persons by this Secretariat that pertain to other Departments as observe by the CIC in its Order (No. CIC/SA/A/2016/001483) dated 01.08.2016.

6. With the above observations, the appeal is disposed of without any further action.

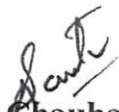

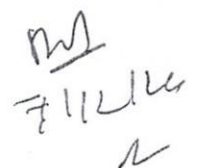

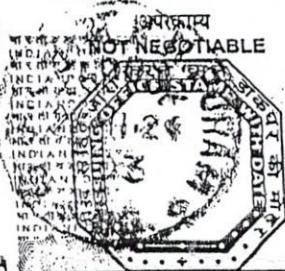

Praying to please direct R1 to R16 secure their Presence before the Honble Court to they should Tender their unconditional apology to all human beings on the globe before court on default thereof IMPOSE penalize punishment for the offences committed by them regarding illegal Public auction and bidding of human beings in Board of Cricket Control of India (BCCI) and auction since 2016 to Present auction by VIVO T.20 IPL (INDIAN PREMIER LEAGUE) T20 on 12-12-2019 at ITC Royal Bengal Hotel Kolkata and etc.

The Court made the following :-

ORDER

IN this petition which has been filed as Private Interest Litigation a Prayer has been made that auction of the players in Indian Premier League conducted by (BCCI) Board of Cricket Control in India. amounts human Trafficking.

The petitioner had not complied with requirements of 14(2) of Karnataka High court PIL Rules 1959. Therefore The writ petition was dismissed by an order dated 19-4-2022 non compliance of the aforesaid of oblique objections.

We have heard learned Counsel for the parties and have perused the records. The Issue raised by the Petitioner in the Public Interest Litigation does not survive of consideration of Indian Premier League Tournament is already ~~dealt with~~ ~~discussed~~ ~~concluded~~. It is pertinent to note that similar issue has already been dealt with division bench of Delhi High Court in PIL and the same has been dismissed vide judgment 26-7-2019 in WP No 5968/19. For the abovementioned reasons we are not inclined ~~to~~ to recall the orders dated 19-4-2022. Accordingly T.A. 2/22 is dismissed.

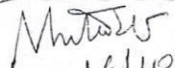
