
ORDER





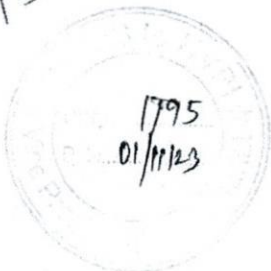
