FYI: The RTI Act has over-riding effect vis-à-vis other laws in as much as the provisions of the RTI Act would have effect notwithstanding anything inconsistent therewith contained in the Official Secrets Act, 1923, and any other law for the time being in force or in any instrument having effect by virtue of any law other than the RTI Act.
- ☐ As per section 7 (8) of the RTI Act 2005, In case of rejection of my application, I kindly request you to provide the reason for such rejection and not just quote a section of RTI. Also, I request you to provide the details of Appellate authority.
- ☐ As per section 8(1) (j) of the RTI Act 2005, the information which cannot be denied to the parliament or a state legislature, shall not be denied to any person.
- ☐ As per section 8(2) of the RTI Act 2005, notwithstanding anything in the official secret Act, 1923 nor any of the exemptions permissible in accordance with sub-section(1), a public authority may allow access to information, if public interest in disclosure outweighs the harm to the protected interests.

- As per section 7(2) of the RTI Act 2005, in case no decision received within 30 days, the PIO shall be deemed to have refused the request.
- As per section 6(2) of the RTI Act 2005, An applicant making request for information shall not be required to give any reason for requesting the information or any other person details except those that may be necessary for contacting him.
- As per section 7(6) of the RTI Act 2005, notwithstanding anything contained in subsection (5), the person making request for the information shall be provided the information free of charge where a public authority fails to comply with the time limit specified in subsection (1).
- As per section 19(5) of the RTI Act 2005, in any appeal proceedings, the onus to prove that a denial of a request was justified shall be on the Central Public Information Officer or State Public Information Officer, as the case may be, who denied the request.
