The Deputy Secretary, Labour Department, E.C.Cell vide his memo no - Labr/17/EC, Date :- 23.04.2024 given direction to the Director, Director of Employment, West Bengal, Kol-69, for query our said matter. As per direction by Deputy Secretary, Government of West Bengal, Labour Department the Director of Employment West Bengal arrange two joint conference / hearing date , we attened there last hearing date attened on 02.08.2024 which held at the Chamber of O.S.D. & E.O., Director of Employment West Bengal. We highlighted there our grievances regarding our matter of subjects with all necessary documents, and submitted one Representation there (enclosed herewith in pdf format), [ in para 2- at the age of 46 yrs E.C.Cell, Director of Employment West Bengal allowed for Exempted Category Registration Card but no opportunity for us in age relaxation allowed in job selection processing, another in para 3 - the District Primary School Council, Uttar Dinajpur, (W.B.) they provisionall appointed some Exempted Category Registration Card holders whose are get a High Court Order Passed by Calcutta High Court, those candidates age was nearly 60 years, But we are 180 persons Exempted Category Registration persons didn't get said facility].

After said meeting, The Director, Director of Employment West Bengal, Kol-69 issued / forwarded a request for Action taken against our said subject to the Secretary to the Government of West Bengal, Labour Department vide memo no. - 4L-8051/22/2024/2063 B(1), Date :-20.08.2024, which we have received on 26.08.2024 since that still now we haven't received any response. In between we done two times R.T.I. Appeal but respective authority failed to replying us( enclosed said R T I prayers).

So sir, this is for your information to you, please do the needful so that the Honb'le Secretary Labour Department, Government of West Bengal as early as possible pass our grivences.
